

ETCP Trainer Recognition Program for ETCP Renewal Credits

Entertainment Technician Certification Program

Qualifications, Application & Licensing Requirements

The Entertainment Technician Certification Program (ETCP), a project of ESTA, evaluates the proficiency of technical personnel working in the entertainment industry and certifies technicians who demonstrate a high level of knowledge, skills and abilities. ETCP Certification is valid for five years and Certificants are required to participate in on-going professional education to maintain their certification. ETCP has an administrative review and recognition process for trainers and it is expected that the training material is relevant to the skill level of the ETCP Certified Technician. Courses taught by ETCP Recognized Trainers provide Certificants with twice as many renewal credits as unrecognized trainers.

Applicants must be ETCP Certified in the area relevant to their training to apply for recognition as a trainer. If you are not ETCP Certified, or you conduct only in-house training, please apply for Training Program recognition. Trainers may apply to receive ETCP Recognition and include the ETCP logo in their promotional literature by completing the ETCP Trainer Recognition Application and the Limited License Agreement.

Qualifications for ETCP Recognition of Trainers

ETCP uses a point system to determine eligibility to become an ETCP Recognized Trainer. A candidate must have 50 points to apply to become an ETCP Recognized Trainer. ETCP is currently recognizing trainers in arena rigging, theatre rigging and entertainment electrical work. Applicants must provide a brief explanation of relevant training experience as it pertains to the points system and provide references. Recognized status will be effective until the trainer ceases to actively conduct classes, subject to review by ETCP. Recognized status is also subject to review by the ETCP Disciplinary Committee should there be a valid complaint.

Fee

There is a \$250 one-time application fee, subject to review. Credit card transactions that are declined or returned checks are subject to a \$25 handling fee.

Awarding Renewal Credits

If, as a recognized trainer, there are certificants in a course seeking renewal credits, or if the trainer is seeking renewal credits, at the conclusion of the course the trainer will submit the names of those attendees, and the number of hours of training, on the Certificant Attendee Sign-in Sheet. The form is available on the website for download.
